### **BACKGROUND**

The Local Government Act 1995 allows for Council to designate certain employee's or positions within Councils organisational structure as designated Senior Employee's.

### COMMENT

When a position within Councils organisational structure is designated as a Senior Employee under section 5.37 of the Local Government Act 1995, there are certain requirements imposed, these are:

- The Chief Executive Officer is to inform Council of each proposal to employ or dismiss a Senior Employee and Council may accept or reject the Chief Executive Officers recommendation.
- If a Senior Employee's position becomes vacant, it must be advertised in a prescribed manner. This is not a requirement if the current incumbent's contract is to be renewed.
- 3) The performance of Designated Senior Employees who are employed for a term of more than one year are required to be reviewed at least once in every year of employment.
- 4) Designated Senior Employees are required to be employed under a Contract.
