sidential Land – Slash all grass and clear all inflammable matter on the land to a height no greater than 50mm and to maintain all grass and all infla the land at a height no greater than 50mm up to and including the 31st day of March 2021.

All Other Land - Create a fire break that is clear of all inflammable matter on the land to a height no greater than 50mm and for a width of no less than three metr (3m) from immediately inside the external boundaries of the property. Where there are trees in the fire break they must be trimmed back to provide a vertical clear of a minimum three and a half metres (3.5m) to allow fire appliances to drive along the firebreak.

it is impracticable for any reason to clear firebreaks or take measures in accordance with this notice, you may apply in writing to your Council before the 15th day I November 2020 for permission to implement alternative measures to prevent the outbreak or spread of a bush fire.
